ANIMALS ARE ALSO ADOPTED FROM ARF'S MOBILE ADOPTION VAN WHICH TRAVELS THROUGHOUT THE TRI-STATE AREA. A TOTAL OF 1,477 ANIMALS WERE RESCUED IN 2015 AND 1,397 WERE ADOPTED. AT THE ARF ADOPTION CENTER THE STAFF IS ALWAYS READY TO HELP POTENTIAL ADOPTERS MAKE AN INFORMED DECISION ON WHICH ANIMAL IS RIGHT FOR THEM, AS WELL AS HELP WITH ANY PROBLEMS THEY MAY EXPERIENCE AFTER ADOPTING. CAT AND DOG RESCUES TAKE PLACE BOTH LOCALLY AND ACROSS THE UNITED STATES. THE CAROLINA TRANSPORT PROGRAM RESCUES ADOPTABLE DOGS AND CATS FROM LOW DEMAND/HIGH KILL NORTH AND SOUTH CAROLINA KILL SHELTERS AND TRANSPORTS THEM TO ARF'S HIGH DEMAND/"NO KILL" ADOPTION CENTER ON THE EAST END OF LONG ISLAND. ARF ALSO
